RESOLUTION NO. 001A (Final)  
2023-2024 BUDGET ADOPTION**

WHEREAS, the Governing Body in and for the Municipality of Socorro, State of New Mexico has developed a budget for fiscal year 2023-2024 and,

WHEREAS, said budget was developed on the basis of need and through cooperation with all user departments, the city's budget committee, elected officials and other department supervisors, and

WHEREAS, The official meeting dates for the review of said documents were duly advertised in the El Defensor Chieftain and on the City of Socorro website [www.socorronm.gov](http://www.socorronm.gov) in compliance with the State Open Meeting Act, and

WHEREAS, it is the majority opinion of this Board that the proposed budget meets the requirements as currently determined for fiscal year 2023-2024, and

WHEREAS, The 2023-2024 budget includes regular maintenance and operational items as well as funding for the following:

1. 1% annual salary anniversary increase.
2. Senior Center Fund
3. Health Insurance split City portion 80% & Employee portion 20%.
4. 5% increase on the Health Insurance plan with State.
5. PERA increase

Additional funding for various capital improvement projects, i.e., Wastewater Collection System, MAP Street Project, COOP Project, Capital Outlay Road and other capital outlay items, and any other funds for which the city is acting as the fiscal agent, and operational items as needed to meet the needs of the City and its citizens.

WHEREAS, The Governing Body of the Municipality of Socorro, State of New Mexico hereby adopts the New Mexico State Procurement Code and Regulations standards as listed in Title 1, Chapter 4, Part 1. Those portions of the State Procurement code as recognized by the city, includes items 1.4.1.1 to 1.4.1.92. Additionally the city adopts the New Mexico Department of Finance and Administrations regulations for Travel and Per Diem listed in Title 2, Chapter 42, Part 2. Those portions of the NM Department of Finance and Administrations regulations as recognized by the city include, items 2.42.2.1 to 2.42.2.14. Any request for copies of Public Records will be provided as per the Inspection of Public Records Act NMSA 1978, Chapter 14, Article 2. (.50/Page, \$10 per disc)

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Governing Body of the Municipality of Socorro, State of New Mexico hereby adopts the budget herein above described and respectfully requests approval from the Local Government Division of the Department of Finance and Administration.
